Rules: Current NRA Conventional Pistol Rules will govern the match. The NRA Classification System will be used. Bring current NRA Classification Cards or Temporary Score Books with you. Rule 19.6 (Assigned Classification) may be used. Unclassified indoor pistol league shooters will be assigned classification for the match based on their current league average. All other unclassified competitors will fire in Master class. All competitors will fire in the Civilian category. Special categories include Woman, Senior and Junior. Ear and eye protection are mandatory. A challenge fee of \$2.00 will be charged for each challenge made. Challenges will be decided by a designated 3-person jury.

Classes: High Master, Master, Expert, Sharpshooter, and Marksman. A minimum of five competitors will constitute a class. Classes will be combined upward as necessary to obtain at least five competitors in a combined class.

Guns: .22 Caliber Pistol or Revolver (NRA Rule 3.4).

Eligibility: Open to any current member of the NRA, or juniors who are members of an NRA Affiliated Club. Competitors may join or renew their membership at a discounted price at the match.

Entry Fee: \$17.00 (includes \$5.50 NRA Registration Fee), payable by cash, check, or NRA points. Make checks payable to **HH&A**.

Entries: Entries will be limited to six relays of 18 competitors each (108 competitors maximum) on a first come, first served basis. Advanced registration is recommended. You may register by email, phone or US mail, using the registration form below. Please ensure that all requested information is provided. Walk-on entries will be accepted up

until the maximum capacity of the match is reached, and will be fit in if and where room is available. No additional relays will be held.

Course of Fire: All matches will be shot at 50 feet using NRA Slow Fire (B-2) and Timed and Rapid Fire (B-3) targets.

- Match #1 - .22 Slow Fire - 20 Shots
- Match #2 - .22 National Match Course - 30 Shots
- Match #3 - .22 Timed Fire - 20 Shots
- Match #4 - .22 Rapid Fire - 20 Shots
- Match #5 - .22 Aggregate of Matches #1-4

Awards: An Open award will be given to the top shooter in each match. Class awards will be given in each individual match and class for every five competitors or high percentage thereof. Open winners will not be eligible for Class awards in the same match. Open and Class awards will be cash only, based on 50% return of the match entry fees (less the NRA registration fees). Match winner and 1st in Class will also receive a medal. Final match results and awards (where appropriate) will be mailed to all competitors.

Special Awards: Medals will be given to the following, if there are three or more competitors within the Special category:

High Woman High Senior High Junior

Refreshments: Light refreshments will be available at the clubhouse during breakfast and lunch at a nominal cost.

Directions: HH&A is located about 5 miles Northeast of Harrisburg, PA. From I-81, get off at Exit 72A (Paxtonia exit). Follow N. Mountain Road to the second light at Old Jonestown Road. Turn left on Old Jonestown Road and go about ¼ mile. Just past Paxtonia Elementary School, turn right at the light onto N. Nyes Road. Follow N. Nyes Road for approximately 1.5 miles. Turn left on Hunters Run Road and go approximately ¾ mile. Clubhouse is on the right. The indoor pistol range is upstairs in the clubhouse.
