FFLs Storage Requirements. The Department of Justice announced a new rule to help enable the safe and secure storage of firearms and published a Best Practices Guide for federal firearms licensees (FFLs). This new rule implements the existing Gun Control Act requirement that federal firearms licensees that sell firearms to the general public (non-licensees) must certify that they have available secure gun storage or safety devices. In addition, today, the ATF published a Best Practices Guide for FFLs. The ATF's Best Practices Guide is designed to assist FFLs in complying with all required firearm laws and regulations that are designed to ensure public safety and the traceability of firearms. Smart Guns. "Personalized smart guns, which can be fired only by verified users, may finally become available to U.S. consumers after two decades of questions about reliability and concerns they will usher in a new wave of government regulation." Click [here](#) for more.

Gun Club Case Resolved. The case of Drummond v. Robinson Township reportedly has been resolved. This case involved a local gun club's effort to stop a township in Western Pennsylvania from enforcing a local ordinance that tried to restrict the gun club's shooting range operations.

San Jose Gun Law. City lawmakers in San Jose voted to require gun owners to carry liability insurance and pay an annual fee to reduce the risk of gun harm by incentivizing safer behavior. INDOOR NOVELTY SHOOTS

We will be holding our last Novelty Shoot of the winter season at the Indoor Pistol Range on Sunday, March 13th, from 1:00 p.m. to approximately 3:30 p.m. This will be a centerfire match using .380, 9mm, or 38 Special caliber handguns. (Note: If you don't have a centerfire handgun, it's ok to use a .22 caliber handgun instead.)

As usual, we will be shooting paper Luck Targets (e.g., poker cards, random numbers, bowling pins, coins, pool balls, dart boards, bullseyes, etc.) at 50 feet. Revolvers and semi-autos may be used.

Red dots are allowed. No holster required. Two-hand hold is ok. Usually 5 shots per target per relay, and about 8 relays.

Cost is \$2 per relay, with a 50% payback to the shooters using the Lewis Classification System. Shoot as many relays as you like.

First-time shooters are WELCOME and our matches are open to the public. Come on out and join us for some fun, and bring a shooting friend with you.

HI POWER RIFLE CLASS

There will be a Hi Power Rifle Class on April 2, 2022 at the HHA clubhouse and 100 yard range. This High Power Rifle Orientation class introduces new shooters to basic rifle safety, basic rifle handling, and basic rifle shooting skills using the AR-15 rifle. This class is designed to introduce new shooters to safely compete in an NRA sponsored High Power Rifle Match. This class uses lecture and practical, hands-on exercises for the training sessions. The class will be taught by NRA instructors and experienced High Power Rifle Shooters.

Class starts at 8:30am and ends about 4pm. Students should bring a bag lunch and dress to be in a class setting and outside on the rifle range. If you do not have an AR-15 we have several club rifles to use in the class.

STRIKER-FIRE CHALLENGE MATCHES

HH&A will be holding five Striker-Fire Challenge combat pistol matches in 2022. No pre-registration is required. Just show up. Range set-up and on-site registration starts at 8:00 a.m., match rules and safety briefing at 8:45 a.m., relay 1 at 9:00 a.m.

METALLIC RELOADING CLASS -- RIFLE & PISTOL CARTRIDGES

There will be an NRA Basic Metallic Reloading Class held at the Harrisburg Hunters & Anglers clubhouse on Sunday, May 29, 2022 from 9 a.m.—6 p.m. This 8-hour class teaches the basic knowledge, skills, and attitudes necessary to safely reload metallic cartridges. The cost for the class is \$50. It covers the instruction, the NRA Reloading textbook, NRA Safety Rules pamphlet, reloading components, and use of all reloading equipment.

Topics include introduction to reloading and reloading safety, using the reloading manual and reloading data, selecting and setting up reloading equipment, requirements for a basic reloading bench, and the actual reloading of several pistol and rifle cartridges.

An NRA Certificate of Completion will be awarded for successfully completing the course. This class is intended for beginners. Class size is limited. UPDATE ON PA CONSTITUTIONAL CARRY

On December 2, 2021, Governor Tom Wolf vetoed Senate Bill 565, which would have provided constitutional carry for Pennsylvania. While unfortunate, this veto came as no surprise to Pennsylvania gun owners. Governor Wolf has a long history of restricting gun rights in the Keystone State. Wolf previously vowed that if constitutional carry legislation reached his desk, he would do everything in his power to ensure it never became the law by utilizing his power to veto the bill.

Constitutional Carry in Pennsylvania

However, the fact that constitutional carry passed both the House and Senate in Pennsylvania should be seen as a big win for gun owners. While a bill passing the House and Senate alone effects no change of law in Pennsylvania, we did get the opportunity to see how various elected officials would vote on this important gun rights issue. And therein lies the real political value, and perhaps even the goal of those who pushed this legislation forward knowing that a veto was almost inevitable: now voters are able to see how much respect for gun rights their elected officials have. With elections for both the House and Senate approaching, how officials voted on Senate Bill 565 provides important insight into how they might vote on future gun rights issues, and even future attempts to pass constitutional carry.

Why Did the Governor Veto Pennsylvania Constitutional Carry?

While Governor Wolf proclaimed in a letter accompanying his veto that constitutional carry would jeopardize the safety of Pennsylvanians, the truth is that it would not allow prohibited persons to carry firearms. Instead, if it had passed, Senate Bill 565 would remove the ability of local issuing authorities to hamper the exercise of the fundamental right to keep and bear arms. While many jurisdictions are responsive and helpful to those wishing to obtain a Pennsylvania License to Carry Firearms ("LTCF"), some localities seem intent on obstructing those who wish to exercise their 2A rights. If anything, the COVID-19 pandemic exacerbated problems in jurisdictions that had historically already made it more difficult to obtain an LTCF. Things got so bad during the pandemic that lawsuits were filed in some areas to force issuance of LTCFs to deserving applicants. Constitutional carry legislation, if passed, would prevent this type of disparity between gun-friendly and non-gun-friendly jurisdictions.

What Is the Future of Constitutional Carry in Pennsylvania?

While it didn't pass during this legislative session, constitutional carry can and should remain a priority for the Pennsylvania Legislature. And don't forget that Pennsylvania will have the opportunity to elect a new governor next year. Find out how your elected representatives voted on this now-vetoed attempt—and remember how they voted when you show up to the ballot box in future elections!

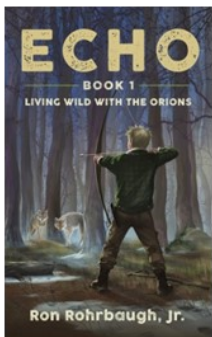

Ever Wonder...?

Is it *Muzzleloader*, *Muzzle Loader* or *Muzzle-Loader Shooting*?

According to Merriam Webster, it is Muzzleloader or Muzzle-Loader.

Vocabulary.com asks: Did you mean Muzzle Loader?

Cambridge asks "Did you spell it correctly?"

All three options are acceptable in The Free Dictionary.

The American Heritage Dictionary accepts Muzzle-Loader or Muzzleloader.

Definitions and Translation.net says Muzzle loader, and in sign language is:



Princeton's WordNet accepts Muzzle-Loader or Muzzle Loader.

Freebase says Muzzleloader.

Collins English Dictionary has both Muzzleloader and Muzzle-Loader.

The glossary on American Firearms.org says Muzzleloader.

Some individuals may use the term Flintlock. But although all Flintlocks are Muzzleloaders(sp), not all Muzzleloaders(sp) are Flintlocks. Flintlock is a hyponym of muzzleloader(sp), e.g., a word of more specific meaning such as *dog and animal*.

Recommendation: Use "Black Powder" Shooting. Or is it Blackpowder?!

RANGE RULES

When using your club's ranges, it is your responsibility to know and understand the club's general ground rules and range regulations. They are published in the club by-laws. Copies of the by-laws are in the magazine rack just inside the front door of the clubhouse. Ground rules and range regulations are posted at each range. You are responsible for your actions on the ranges, so take the time to learn the club rules and be sure to follow them.

If you have any questions on club rules, or feel you need one-on-one training, please contact an officer of the club, or one of the board of directors, who will help you out.

Remember – safety is your responsibility. Make it your top priority.

INDOOR PISTOL RANGE RULES REMINDER

A few members have been using B27 or other full body sized targets on the Indoor Pistol Range. Targets of this size are not allowed on the Indoor Pistol range for safety reasons. The only time they are allowed on this range is for approved and sanctioned training events such as the Handgun Safety Classes and Law Enforcement training. If you have any doubt about what targets you are allowed to use, check the by-laws or read the sign posted in the range lobby.

MEMBERSHIP RENEWAL FORM, DUE BEFORE JANUARY 1

- This form can **only** be used if you are **renewing a membership**. If you were a member in the past 2 years, you may use this form; otherwise, you must use a New Member Application form to obtain membership.
- If changing from an Adult to Family membership, please use a New Member Application form and follow the instructions.
- If a previous year's junior member is 16 as of January 1, they must renew as a separate member. This includes children that are part of a family membership.
- **If you do not renew your membership by December 31, your privileges to use any club facilities will be suspended (card keys will be disabled) until your renewal is received and processed. Allow at least two weeks to receive your membership card after we receive your renewal.**
- ADULT: 22-61 years, JUNIOR: up to 15 years, YOUNG ADULT: 16-21 years, SENIOR: 62 years and older (ages as of Jan. 1).
- Make checks payable to HH&A. Applicant will be responsible for all bank fees for a check returned for any reason.
- **MUST mail form and check to: HH&A, c/o Membership, P.O. Box 4129, Harrisburg, PA 17111.**
