POLICE PISTOL COMBAT (PPC) MATCHES

It's almost that time of year again! HH&A's first PPC match of the 2024 season is coming up on Saturday, April 6th.

Our matches will be held monthly on the first Saturdays, from April through October, at PPC Range #2. Match dates are as follows:

- April 6 (Orientation & Training Day)
- May 4
- June 1
- July 6
- August 3
- September 7
- October 5

We will have 5 Gun Classes to shoot in and will run 5 relays per match date, as long as we have enough shooters.

Cost is \$5 per relay. Shoot as many relays as you like, pending availability of space. A minimum of 50% of fees taken in will be paid back as cash awards to winners using the Lewis Classification System. Each Gun Class will be handled separately for awards.

We've added something new this year. An End of Season Award raffle (gift cards and/or shooting accessories) will be drawn in November for those shooting more than 10 relays during the season.

On match days, the security gate opens and range setup/registration will begin at 8:00 a.m. Safety briefing at 8:50 a.m. Hammer down at 9:00 a.m. We are usually done by noon.

We run a cold range. Do not bring loaded guns to the range. Guns must remain unloaded and holstered or cased, except when under the direction of the range officer on the firing line, or when in a safe gun handling area.

BASIC HANDGUN SAFETY COURSE

U.S. LAWSHIELD SEMINAR

SUMMER PISTOL LEAGUE

The HH&A 2024 Summer Pistol League (Bullseye) starts on April 24th and runs from 6:30 - 8:30 p.m. every Wednesday evening through August 21st at our Outdoor Pistol Range.

We begin with a free practice night (2 relays) on Wednesday, April 17th, so the shooters can get their guns sighted in at 25 yards.

The one-time League Registration fee is \$10 for the 1st gun, and \$5 for a 2nd gun (optional).

Match fees are \$1.00 per relay. Includes 3 targets: 1 Slow Fire, 1 Timed Fire, and 1 Rapid Fire.

Four relays are held each evening, weather permitting. Shoot as many as you like. Course of fire is the 30-shot National Match Course. All targets are shot with one hand at 25 yards using turning targets.

Any safe rimfire or centerfire semi-auto pistol or revolver (.32 to 45 caliber) may be used. Both iron sights and red dot optics are allowed. Bring your own stapler, staples, pasters/tape, pencil or pen, and empty chamber indicator (ECI). Ear and eye protection are mandatory. Brass catchers may be used.

All scoring will be done by shooters downrange. Pass scorecards right, score left. Scores will be recorded and averaged for the league by gun class, and cash awards will be given out at the end of the season using Lewis Class.

Note: Two-handed shooting will be allowed, but scores will not be eligible for awards.

STRIKER-FIRE CHALLENGE MATCHES

HH&A will be holding five Striker-Fire Challenge combat pistol matches in 2024. No pre-registration is required. Just show up.

Range set-up and on-site registration starts at 8:00 a.m., match rules and safety briefing at 8:45 a.m., relay 1 at 9:00 a.m.

Five continuous relays will be run at our Police Pistol Combat Range #2 from 9:00 a.m. until around noon. Cost is \$10 per relay. Fifty rounds are required per relay fired (40 for Concealed Carry).

Three Gun Classes will be used: Stock (Iron Sights only), Open (Optics allowed) and Concealed Carry(Iron Sights Only, 3.7" barrel max, 2 mags needed per stage). Shoot as many relays as you like (pending availability of space), and in either or both Gun Classes. Cash awards for each Gun Class will be determined using the Lewis Classification System.

INTERMEDIATE HANDGUN CLASS

This course is a prerequisite for more advanced classes, such as the HHA Defensive Handgun Skills Class. Students will review the basics and experience more intense hands-on handgun training. This class will be limited in size and students must have previously completed the Basic Handgun Safety class WITHIN THE PAST TWO YEARS. NO EXCEPTIONS.

Students are required to have a centerfire handgun (.22LR rim fire handguns are not acceptable); semiautomatics must be a .380/9mm caliber or larger, and revolvers must be double-action only .38 caliber or larger. Students must also have two magazines or speed loaders, their own eye and ear protection, and provide their own ammunition (200 rounds).

All instructors are NRA-Certified. The course is \$65.00, we accept cash or check only no credit cards.

An optional Long Shot Contest follows the Woods Walk. Bring extra rounds if you plan to shoot. Cost is \$1. Winner takes all.

HH&A LEGISLATIVE & REGULATORY OBSERVATIONS

Some positive news this month. Louisiana and South Carolina have become the 28th & 29th states respectively to enact the constitutional carry provision for law abiding citizens. In other states the attacks on honest citizens continue. It is disheartening to see individual states arising as either havens of freedom or socialist democratic style places to live. This weakens the overall fabric of our nation. There is no doubt that a significant number of leaders want the government to take over even larger portions of your life. Here in Pennsylvania, we have a fairly good amount of liberty, but as our society continues to settle into a condition where more and more individuals rely on the government, and worse, don't care, our battles will intensify.

COMPETITIVE YOUTH BB GUN RIFLEMEN TEAM NRA Sectional

This match is based on the age of the shooter. There is no test given in this match. HHA entered 1 team of 5 in the BB1 category (age 13 to 15), 1 team of 4 in the BB2 category (age 10 to 12) and 1 team of 5 in the BB3 category (age 8 to 9). Overall, there were 15 teams representing 5 groups with a total of 80 shooters. Overall, the shooters placed from 18th to 77th. In the BB1 Category, the team placed 5th. In the sitting position for the BB1, Michael Reilly placed 3rd. In the BB2 category, the team placed 3rd. In the BB3 category, the team placed 1st. In the BB3 category, Martin Birch placed 3rd overall, 1st in standing and 2nd in kneeling. Grant Hess took 3rd in standing. The match's scores will be sent to the NRA and will now be combined with all the NRA sectional matches held across the country. The teams and shooters will be eligible for more awards at the national level. Another great match for all these shooters.

COMPETITIVE YOUTH BB GUN RIFLEMEN TEAM Spring Fling



The match was attended by 19 teams from 8 clubs. There were a total of 115 shooters participating. Each shooter is required to take a safety test worth 100 points. A perfect test score was achieved by 11 shooters, including 3 from HHA. HHA had 2 teams participating. They finished in 4th and 14th. The shooters from HHA placed 3rd, 13th, 17th, 28th, 35th, 36th, 42nd, 51st, 65th, 67th, 68th, 72nd, 84th, 95th, and 102nd. Their next match is the State Match on April 6 in Centre Hall, PA. When at the ranges, please utilize the recycling buckets provided for spent brass, steel and aluminum cases. You can throw them all in the same recycle bucket since we recycle all three types of cases now.

We recycle the brass in two ways: (1) we sort by caliber and sell all brass suitable for reloading to club members at very good prices, and (2) we sell the remainder, along with the steel and aluminum cases, to a salvage company.

All funds made from sales and recycling are used to help fund the club's growing youth programs. Thank you for your continued support.
